

MODERN SLAVERY ACT 2015 STATEMENT

INTRODUCTION

Modern slavery is a crime and a violation of essential human rights. It takes many forms, including slavery, servitude, forced and compulsory labor, and human trafficking, all of which involve depriving a person of their liberty in order to exploit others for personal or commercial gain.

HIFI Group SA has a zero-tolerance approach to modern slavery, and we are committed to acting ethically and with integrity in all our dealings and relationships and to implement and enforce effective systems and controls to ensure modern slavery is Does not exist anywhere or in one of our supply chains.

This statement sets forth HIFI Group SA's and its subsidiaries commitment against slavery and human trafficking within its business operations and supply chains. It details the actions taken by the group in accordance with the Modern Slavery Act 2015, covering the fiscal year ending December 31, 2023.

We are not aware of human trafficking/slavery allegations against any of our suppliers, but if this were the case, we will take immediate action against the supplier and report it to the authorities.

HIFI Group SA is ultimately responsible for ensuring that this Policy complies with our legal and ethical obligations and that all persons under our supervision comply with it.

HIFI Group SA is responsible for enforcing this policy on a daily basis, monitoring its application and effectiveness, answering any related questions and reviewing internal control systems and processes to ensure they are successfully combating modern slavery.



All levels of management are responsible for ensuring that their subordinates understand and comply with this policy and receive appropriate and ongoing training on the policy and on modern slavery in the supply chain.
